DESTINATION LUTON

There is so much to be excited about in Luton right now, the town has the potential to become a real destination for visitors, with the long-standing role that some of our anchors will play as well as the impact of some really transformational major events to come. The panel will focus on Destination Luton and the emerging visitor economy offer in the town. With the Premier League football club and the new stadium being one of the main attractions of a strong visitor economy in Luton, and additional numbers coming through the town centre for football and other live events like the Radio 1 Big Weekend festival. We will hear from Deloitte about the opportunities for the town from both the stadium development and from Luton Rising about the contribution of London Luton Airport on to not only attracting more people to visit Luton as they come through the airport, but the wider benefits the Airport has to the wider economy. The Arora Group will discuss their development plans and ambitions for the Luton Hoo to host the Ryder Cup - another major catalyst for building a strong and lasting destination offer that can appeal to lots of different audiences. Rachel Gillis from Visit England will outline the emerging opportunities in Luton and the wider area, which impresses on us the need to develop a new visitor economy plan that harnesses the legacy and opportunities of these developments and events and seeks to build a sustainable destination offer around arts, culture, heritage, sport, hospitality and education in the town.

Councillor James Taylor Portfolio holder for Regeneration and Inclusive Growth

Councillor James Taylor is the Portfolio Holder for Regeneration and Inclusive Growth at Luton Council and a Director of Luton Rising. Cllr Taylor is a ward Councillor for High Town and first joined in 2015, re-elected in 2023 and now part of the Executive delivering the 2040 vision.



Robin Porter Chief Executive, Luton Council

Robin Porter has been the Chief Executive for Luton Council since May 2019. In this role, Robin is responsible for more than 2,700 staff and the delivery of circa 730 services, as well as a budget of £500m – all focused on supporting Luton's vibrant and diverse 225,000 population, and working with partners to deliver the collective 2040 ambition to eradicate poverty. Robin is also the Shareholder Representative for all of the Council owned companies who in part manage the Councils £3.5bn of commercial investments. Robin has now been part of the Luton community for 16 years. Before taking up his current appointment he held a number of roles including Deputy Chief Executive; Director of Transformation; and Chief Operations Officer for London Luton Airport Limited. Before joining Luton, Robin worked as a senior manager in the private sector in the project finance industry and before this he was a British Army Officer.
